MINUTES OF MEETING HELD SEPTEMBER 17, 1945.

A business meeting of the Football Officials' Association of Central Pennsylvania was held Monday September 17, 1945 at the Y. M. C. A. Harrisburg, Penna. President E. E. Miller presided with 42 members present.

Minutes of the Annual Business Meeting held November 20, 1944 were read and approved.

Roll call of members was requested by the President.

Treasurer's report showing receipts of \$477.81 and disbursements of \$460.28, leaving a balance as of Sept. 17, 1945 of \$17.53 was read and approved by the auditing committee consisting of Earl W. Killenger and G. H. Dunkle.

Election of Officers: Nominations for officers for the Association for the year 1945 were opened by the President E. E. Miller and the following members were nominated and voted on separately: President E. E. Miller, Vice-President Jas. R. Peifer. It was moved by Robt. Schreck and seconded by Edgar Mitchell that the Secretary cast the ballot for the President and Vice-President. Motion carried.

Members nominated for the executive committee were; Mr. Clarence R. Beck, William Doremus, J. J. Furjanic, Edgar Mitchell and Earl McMillen. Results of the election of executive committee:-Clarence R. Beck & William A. Doremus.

Resignation of G. W. Gelwicks was read. Mr. Robt Schreck moved that we accept the resignation and also recommended that we place the name of G. W. Gelwicks on the honorary roll. Motion seconded by Wayne S. Metka. Motion carried.

A motion was made by Robt. Schreck and seconded by Samuel Angle that we accept the Charter to be presented to us by the P. I. A. A. Motion carried.

Mr. Robert Schreck requested that we ask for representation on the Board of Control of the P. I. A. A.
