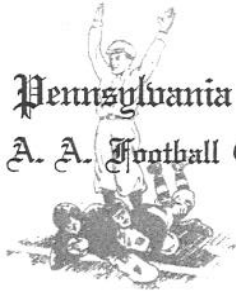

MINUTES OF MEETING HELD SEPTEMBER 20, 1948.

A business meeting of the Central Penna Chapter P. I. A. A. Football Official's Asso. was held Monday September 20, 1948 at the Park Dept Office, Harrisburg, Penna. President James R. Peifer presided with 48 members present.

Minutes of the previous business meeting held September 15, 1947 were read and approved.

President James R. Peifer requested roll call of officers and members.

Treasurer's report showing receipts of \$695.27 and expenditures of \$493.70 for the year, leaving a balance of \$201.57 in the Peoples Bank of Steelton as of Sept 20, 1948 was read by the Treasurer. An auditing committee was appointed by the president, namely Mr. Harry Sherman, Mr. John T. Beck and Mr. Harold J. Thomas. The records of accounts and balance were approved by the auditing committee but they insisted that Check No.10 payable to Ralph R. Farina in the amount of \$13.60 for postage, cards and telephone calls for the year 1947-1948 be deleted from the expenditures as listed on the treasurers report of Sept 20, 1948 making a balance of \$215.17 and that this expenditure be carried over in next years report. The treasurer's report was approved as read.

The following officers were elected for the year 1948-1949. President James R. Peifer-Vice President William A. Doremus. Members of the advisory board elected were Samuel Angle and David R. Dayhoff.

It was announced by the President that Monday September 20, 1948 and the following four Monday's, Sept 27, October 4, 11, 18 ~~XXXXX~~ would be recorded as official interpretation meetings and that it would be necessary that members attend at least 80% of these meetings. The secretary was ordered to notify all members of the official interpretation meetings by card.

President James R. Peifer appointed the following committee to arrange matters for the Mid-Season Frolic October 18, 1948 and the Annual Banquet November 29, 1948. *FARINA, Schiffer, Dayhoff, Metka & Sherman*

A motion was made by William Pelton that flowers be sent to Mr. Richard Walton sports writer of the Patriot-Evening News. Motion seconded and approved.

Meeting adjourned and Interpretation meeting followed.

A motion was made by Mr. William Doremus and seconded by David R. Dayhoff that our yearly dues be reduced to \$5.00 per year. Motion carried.
