
Dear Sev:-

Minutes of Annual Meeting, November 15, 1954

1. President Donald E. Enders presided.
2. Action was taken on four applications for membership :

All were accepted.

3. The Chapter By-Laws, as approved by the Executive Committee, and under which the Chapter operated this year were discussed, Article by Article. An amendment was made thereto which would authorize payment of an annual salary to the Secretary-Treasurer in the amount of \$50.00. Several other clarifying amendments were also made. The By-Laws, as amended, were then accepted.
